## Introduction

In September 2003, at an open meeting in the village hall, the idea of a parish plan was first introduced to Rearsby by the Leicestershire & Rutland Rural Community Council. Following this initial meeting, and the endorsement of the Parish Council, a Parish Plan Group was formed consisting of volunteers from the village whose remit was to develop such a plan. They have been pursuing this project since that date.

In October 2004, a questionnaire was sent round to all residents in Rearsby asking for their opinions on a number of key issues facing the village. The results of that questionnaire have now been analysed and form the basis of this report, its 48 recommendations and action plan.

A parish plan is a strategic document to enable a village to have a say about how it wishes to develop in the future. It tackles social, economic and environmental concerns such as housing, education, health, heritage, traffic and transport, policing, and services and amenities. It is an important document because it reflects local views, guides local policy making, galvanises people into action, and can be used to solicit funding from local providers.

The Rearsby Parish Plan is firmly based in the opinions of the people of Rearsby. 248 households completed the questionnaire out of a total of 387 properties, a response rate of approximately 65%. This is a high response rate for a questionnaire and provides substantial backing for the recommendations found here. Quite a number of people have also offered their help in driving some of the initiatives in the plan – a heartening sign of the collective strength of our community, which first became apparent during the bypass campaign.

The answers from the Village Hall Redevelopment Questionnaire, which was distributed to all villagers in January 2004, have also been integrated into the plan at certain points as a redeveloped hall will enable the village to provide some of the new services and activities people in the village require. (A summary of the results of the Village Hall Redevelopment Questionnaire can be found after the action plan at the end of the document.)

Taking into account the levels of response to both questionnaires, the Parish Council have now formally adopted this document to guide its decision making and, in partnership with other village groups and service providers, will seek to ensure that its recommendations are implemented within the appropriate timescales.

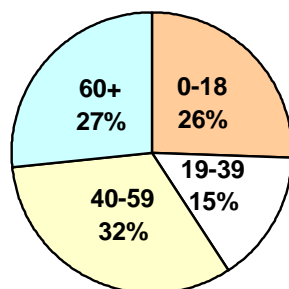

## The population of Rearsby

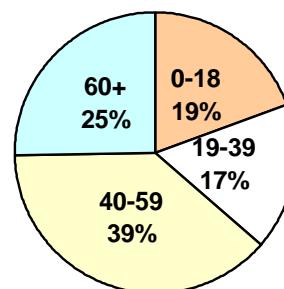
Questions 1-2 were about the population of Rearsby. Results were as follows.

- There are 520 adults and 141 children living in the 248 households who responded to the questionnaire – a grand total of 661 people.
- Approximately two-thirds (68%) of households have two adults living there.
- Two-thirds (67%) of households have no children living there.
- 325 males and 326 females were identified – virtually a 50-50 split.
- The highest number of both males and females are in the age group 40-59 – 105 males and 126 females representing approximately 32% of all males and 39% of all females.
- The second and third highest age categories for both males and females are the 60+ age group which has approximately 27% of all males and 25% of all females and the 0-18 age group which has approximately 26% of all males and 19% of all females.

## Conclusions

Although the most represented demographic group is aged 19-39, the Parish Plan Group notes that, generally speaking, people aged 19-39 are likely to be more robust and less vulnerable than the 60+ and 0-18 groups, who between them comprise nearly 50% of the population.

## Recommendations

- R1 As there is a substantial elder and younger population in Rearsby, their needs should be well represented in local policy and decision making.

## Quality of life

Questions 2-6 dealt with what people like and dislike about Rearsby.

- What people most like about Rearsby are in order of preference:
  1. The countryside
  2. Village life
  3. Peace and quiet
  4. Safe environment
  5. Community spirit
  6. Quality of housing
  7. Heritage and history
  8. Facilities and amenities
- Amongst additional likes are the school, accessibility of the village for work, travel and nearby towns, and the friendliness of the village.
- What people most dislike about Rearsby are in order of least preference:
  1. Traffic
  2. Lack of facilities and amenities
  3. Anti-social behaviour
  4. Litter and rubbish
  5. Urbanisation
  6. Standard of public transport
  7. Lack of community spirit
- Amongst additional dislikes are dog fouling and the lack of a village shop.

## Conclusions

There are clear benefits to living in a village, most notably the relaxing and peaceful pleasures of the countryside situated away from the hustle and bustle of the town. Village life and community spirit are clear pluses and the level and type of crime are altogether less significant compared to a town. However, there are some drawbacks to living in a village. There are less services and amenities in a village, but then villages would be towns if they were overrun with services and amenities. A village shop, however, would be most welcome. Traffic can be an unwelcome intrusion, though less so now we have a bypass, and anti-social behaviour is unacceptable whether you live in a town or a village. (Most of the dislikes which came up here are mentioned more specifically in other sections of this plan, and further conclusions and recommendations are deferred to these other sections.)

## Recommendations

- R2 A series of 'countryside values' should be developed on living in Rearsby. These would be a guide to policy and decision making in line with the values featured in the Village Design Statement (VDS).

## Heritage & environment

Questions 7-14 dealt with heritage and environmental issues.

- 74% of respondents are satisfied with the state of the footpaths (pavements and rights of way) through Rearsby; 21% are not satisfied.
- 67% are satisfied with the state of the village hedgerows and trees in and around the village; 29% are not.
- 85% are in favour of projects to enhance the appearance of the village; 9% are not.
- 57 residents wish to take part in heritage and conservation initiatives.
- Amongst the parts of the village that require improvement from a conservation or environmental point of view, residents listed: the buildings opposite the Wheel, the barn on Brookside, the coppice area on the left of Station Road (near the bridge), the railings alongside the brook and the brook itself.
- 63% of respondents think visitors to the village should be encouraged; 22% are against.
- 8 residents are prepared to offer accommodation to visitors.
- 62% are against a twinning arrangement and 23% in favour.

## Conclusions

Residents are generally happy with the environmental state of the village including hedges, trees and footpaths, and many of the areas highlighted for improvement are already on the Parish Council's agenda such as the railings alongside the brook. However, more can be done and, in this respect, it is very encouraging to note the numbers of people who are in favour of projects to enhance the appearance of the village and are prepared take part in heritage and conservation initiatives themselves.

Although there is a clear majority in favour of visitors to the village, a twinning arrangement with a village in another country is not favoured.

## **Recommendations**

R3 A larger heritage group is needed with a remit to develop environmental and heritage improvements.

### **Pathways, coppices, trees & hedges**

R4 Our pathways and footpaths need better maintenance including the removal of moss and nettles and the cutting of grass verges. This should include Conker Field, Station Road near the bridge, and the paths around the Church.

R5 New trees and hedges should be planted throughout the village and its outskirts and existing trees and hedges maintained. Owners should be encouraged to maintain their trees and hedges. (VDS Guidelines 7, 13, 14, 15 & 16 apply.)

### **The brook environment**

R6 The arrangements for maintenance of the brook including the state of its banks should be reviewed.

R7 The railings alongside the brook should be replaced with fencing of a more rural aspect. (VDS Guideline 44 applies.)

R8 Ways should be found to alleviate traffic congestion around the school and improve safety.

R9 Parking on the grass verges by the brook on Mill Road should be discouraged.

### **Buildings**

R10 Owners should be encouraged to maintain their property, particularly old and/or public buildings, where they are falling into disrepair and affecting visual amenity. (VDS Guidelines 29, 30 & 31 apply.)

### **Litter and dog fouling**

R11 An initiative on litter-picking is needed to clean up the village.

R12 The number of litter/dog fouling bins in the village needs reassessing.

R13 A new dog fouling initiative is needed.

### **Visitors & twinning**

R14 Accommodation to village visitors should be publicised.

R15 Rearsby's heritage and history should be publicised to a wider audience.

R16 A twinning arrangement should not be pursued as it requires official endorsement from the Parish Council and therefore a majority of residents/respondents need to be in favour of it.

## Services & amenities

Questions 15-29 dealt with services & amenities.

- 73% of respondents are in favour of an all-purpose village shop; 19% against.
- 35% are in favour of a community village shop; 46% against.
- All the current services offered by the post office are well used apart from loans & car insurance.
- 77% of respondents are satisfied with the current range of services provided by the post office; 11% are not satisfied.
- The main suggestions for additional services are: general food shop (20), car tax (14), newspapers (12), banking (8), photocopying (7), Saturday opening (5), dry cleaning (2).
- Only 22 people use the mobile library service, although more would probably use it if it visited at more conducive times and offered DVDs/CDs and videos.
- 56% do not know what travelling shops/mobile services are available in Rearsby; 43% do.
- Of suggestions for additional mobile services, 14 indicated they would like a greengrocer/general food service, 6 fast food, 3 a hairdresser and 2 a newspaper service.
- 40% are in favour of a LETS scheme for the village; 39% against. 20 people are willing to help develop a scheme.
- 33 people wish to use a public allotment.
- 59% think the play park should be enhanced with extra equipment and picnic benches; 32% are against.
- 76% are in favour of a 'welcome pack' for new residents; 15% are against.
- Of other services & amenities the village could use, the main suggestions were: a shop (14), a youth/teenage group (10), a retired group (5), a doctor's/medical centre (4).

## **Conclusions**

There's a clear demand for an all-purpose village shop (as opposed to a community shop). The post office is performing an excellent multi-service to the village and must be retained at all costs; it may perhaps be able to offer one or two additional services, though its size makes it unsuitable for an all-purpose shop. Travelling shops/mobile services need to be better publicised including the mobile library.

A significant number of people would use a LETS bartering scheme and a public allotment, and extra amenities in the play park would be welcomed.

The demand for other types of services & amenities such as a doctor's surgery were highlighted in the Village Hall Redevelopment Questionnaire and are dependent on getting funding for the redevelopment. Services & amenities for younger people are dealt with in the youth section of this document.

## **Recommendations**

R17 The requirement for a village shop, but not a community shop, should be pursued.

R18 The post office should be advised of the questionnaire results.

R19 The current travelling shops/mobile services in the area, including the mobile library, and the services the post office offers should be more widely publicised, and an assessment made for further such services.

R20 A LETS scheme should be developed.

R21 Provision of extra allotment space for villagers should be pursued.

R22 Extra equipment and picnic benches should be provided for the play park.

R23 A 'welcome pack' should be developed for all new Rearsby residents.

R24 The provision of new services in a redeveloped village hall should be pursued in line with the requirements of the January 2004 Village Hall Redevelopment Questionnaire.

## **Health & social services**

Questions 30-34 dealt with health & social services.

- 43 people indicated they were disabled including 9 at Rearsby Residential Home. No disabled children were indicated.
- 36 people have general poor health including 9 at Rearsby Residential Home. No children with general poor health were indicated
- 7 people indicated they needed help of one sort or another excluding Rearsby Residential Home who also put in a general plea for help.
- 33 people offered to help elderly, infirm or disabled people with simple day-to-day tasks.

### **Conclusions**

The incidence of disability and general poor health is low in Rearsby, although there may be some who would not classify themselves as 'disabled' or 'infirm' but who might benefit from greater awareness of the support services available. Rearsby Residential Home is a special case and needs support from the village.

Fortunately, there are a large number of people who are willing to help our elderly, infirm and disabled people.

### **Recommendations**

R25 People who indicated they needed help in the village, especially Rearsby Residential Home, should be supported by volunteers.

R26 The help and support services in the area should be publicised.

## **Economy, employment, training & education**

Questions 35-44 dealt with economy, employment, training & education.

- 57% of respondents favour the development of small businesses only in the village, with 36% favouring no businesses at all.
- 52% support the expansion of business development around Rearsby Business Park; 42% are against.
- 6 people want information on training/retraining. 27 are interested in learning for interest/pleasure, 20 in IT training, 3 in retraining, 3 in qualifications, 2 in return to work training, 1 in language learning.
- 113 people are satisfied with the pre-school facilities; 10 are not. The lack of a voucher system was mentioned by 4 people. Others want longer sessions encompassing more age groups.
- 84 people stated their expectations of the primary school were being met; only 5 said they were not. The general feedback was extremely positive.
- A variety of education and other training services were suggested for the village such as an after-school club, adult learning/evening classes and computer courses.

### **Conclusions**

Respondents support small business development or no development, and are happy to see (small) business development around Rearsby Business Park on the other side of the bypass.

The pre-school facilities and the school itself are very well received and appreciated. There is a small but significant interest in adult education and training, which could be catered for.

## **Recommendations**

- R27 The preference for small business development and the support for expansion around Rearsby Business Park should be brought to the attention of planning authorities with a view to influencing business planning policy in Rearsby.
- R28 The people interested in training/retraining should be directed to appropriate learning resources.
- R29 Education and training providers for the region, including pre-school and after-school providers, should be widely publicised.
- R30 The school and pre-school should be advised of the findings of the questionnaire.
- R31 The provision of training and education services in the village hall should be assessed especially learning for interest/pleasure and IT training.
- R32 The provision of training and education services in a redeveloped village hall should be pursued in line with the requirements of the January 2004 Village Hall Redevelopment Questionnaire.

## Housing

Questions 45-47 dealt with housing issues.

- 82% of respondents support resistance to housing infill between the bypass and the village; 13% did not.
- 61% of respondents support small-scale housing developments only (defined as 3-4 houses at a time); 31% do not.
- Of the type of housing villagers favour (if any), preferences are (in this order):
  1. Affordable housing
  2. No housing at all
  3. One/two bedroomed flats/houses
  4. Semi-detached, three bedroomed houses
  5. Sheltered housing
  6. Housing association accommodation
  7. Four bedroomed detached
  8. Five bedroomed executive

## Conclusions

There is a clear majority in favour of resisting housing infill between the village and the bypass. Most people favour small-scale housing development only (3-4 houses at a time), and they favour affordable housing as their preferred type of housing development.

## Recommendations

- R33 The village's rejection of housing infill between the bypass and the village should be brought to the attention of planning authorities with a view to influencing housing development policy in the area. (VDS Guideline 1 applies and local plan policies CT/1 & CT/2.)
- R34 Our views on preferred type of development, ie 3-4 houses at a time, and preferred type of housing, ie affordable accommodation, should be brought to the attention of planning authorities with a view to influencing housing development policy in Rearsby.
- R35 The implications of development in Rearsby in the near future should be discussed more thoroughly at local level with a view to influencing Charnwood Borough Council's Local Development Framework (2006-2016) and other development plans.

## Information & communication

Questions 48-50 dealt with information & communication issues.

- 91% of respondents are happy with the information they are getting about what is going on in the village; 5% are not.
- Most people are happy with our communication and information outlets such as *Rearsby Scene*, the noticeboards, the post office, and the *Village Directory*. A strong majority are happy with the Rearsby.net website, the Parish Council website and the Parish Council as information and communication outlets, although quite a lot of people did not have an opinion one way or the other suggesting they weren't using these sources.
- As regards suggestions for improvements, these included better noticeboards, more leaflet drops and greater awareness of what the various information & communication outlets offer and where they can be found.

## Conclusions

People are generally happy with the information they receive and the various communication outlets. Improvements can be made, however, such as the generation of more awareness and interest in the Parish Council.

## Recommendations

R36 The siting and maintenance of noticeboards should be reviewed.

R37 The provision of information to the village from the Parish Council should be improved.

## Traffic & transport

Questions 51-57 dealt with traffic & transport.

- 63% of respondents do not use public transport through Rearsby; 34% do.
- As to why people might use them, 72% did not answer, 13% replied better services/more information on services/cheaper fares, 7% replied 'nothing', and 6% replied with a variety of reasons.
- Two-thirds of respondents know about the public transport services provided for Rearsby including timetables and destinations; 29% do not.
- As to how transport services could be improved, 71% did not reply. Of those who did, the main suggestions were: more/better bus shelters, more frequent services, services along Station Road, services to Loughborough, more direct services to Leicester, train services from Rearsby.
- 74% approve measures to improve walking and cycling amenity in Rearsby; 12% do not.
- 73% approve of traffic calming measures in the village; 23% do not.
- As to the most favoured type of traffic calming, the preferences are (in order of most preferred):
  1. Environmental improvements, eg trees by road
  2. 20 mph speed limits
  3. Restrictions of road, eg by larger pavements
  4. One-way system for Brook Street and Brookside
  5. Coloured markings on road & priority system like at Ashby Folville/Asfordby
  6. Humps
  7. Mini-roundabouts

## **Conclusions**

Public transport is an important issue to a significant number of Rearsby residents, though there is no clear consensus on the way forward, particularly as buses are currently fairly frequent on the main route between Melton and Leicester. We must preserve the services we have, but more research needs to be done on the future envisaged for public transport in our county before approaching providers for improvements.

A good majority want cycling and walking provision improved.

Following the completion of the bypass, traffic calming to stop speeding and potential 'rat-runs' through the village, especially at rush hour, is now seen as an important issue. A variety of traffic-calming measures should be considered based on the main preferences.

## **Recommendations**

R38 The current state of integrated transport policy in the area should be assessed in order to clarify our attitude to public transport.

R39 A proper cycleway along the main road as a continuation of the projected one from Syston to East Goscote (Broome Lane) should be developed. (Local plan policy TR/13 applies.)

R40 Walking and cycling groups should be formed for Rearsby.

R41 Traffic calming for the village, taking into account the main preferences expressed in the questionnaire, which suggest a ruralisation of the main road, should be discussed with the appropriate authorities. At the same time, the overall design aspects of the main road should be discussed as part of a long-term plan to enhance its appearance.

## Crime & policing

Questions 58-62 dealt with crime & policing issues.

- 45% of respondents are happy with the policing of Rearsby; 46% are not.
- The particular aspects of policing they are unhappy with (in order of most unhappy) are:
  1. Lack of police presence
  2. Dog fouling
  3. Anti-social behaviour by young people
  4. Vandalism
  5. Motoring behaviour
  6. Anti-social behaviour by others
  7. Theft and burglary
  8. Drugs and/or drunkenness
  9. Other
- Other aspects of crime & policing respondents are unhappy with include litter, dogs and noise.
- 48% of respondents know where to phone to contact the dog warden, police and our community police officer; 49% do not.
- 48% favour funding a Police Community Support Officer for Rearsby with other villages; 40% do not.

## Conclusions

There are mixed reactions over the effectiveness of policing in Rearsby, opinion being fairly evenly divided. The lack of a police presence tops the list of concerns. There is little or no serious crime, anti-social behaviour and vandalism topping the list. (Dog fouling is dealt with in the 'Heritage & environment' section.) There is a majority in favour of funding a Police Community Support Officer.

## Recommendations

R42 Our local policing unit at Syston should be advised of the findings of the questionnaire regarding crime and policing, particularly our concerns over the lack of a police presence.

R43 Initiatives with the police to reduce anti-social behaviour and vandalism should continue.

R44 The contact details of the police, our police community officer and the dog warden need to be widely publicised.

R45 A Police Community Support Officer should be appointed for Rearsby where financially viable.

## Youth issues

A separate part of the questionnaire was used to tackle issues purely to do with our 11-18 year-olds. There were 43 responses to the nine questions of youth questionnaire covering 69 young people.

- The number of respondents per age range were:
  - 11-14 year-olds – 33
  - 15-16 year-olds – 20
  - 17-18 year olds – 16.
  
- There were 34 replies as to what young people most liked about living in Rearsby: 13 citing the quiet nature of the village, 9 referring positively to the village location, plus many positive references to the fact that larger conurbations are within easy reach. 8 felt that Rearsby offers a pleasant environment and/or community to live in, and 8 valued their friends living in the village.
  
- There were 33 replies as to what young people most disliked about living in Rearsby. The main message was very clear – the young people of Rearsby feel strongly that there are not enough facilities for their age group, with 19 stating their dissatisfaction at the current level of provision. There was also a feeling that young people are treated with suspicion by adults for ‘hanging around’ near the bridge/on the park, but adults fail to recognise that they do not have any formal meeting place.
  
- Of the current playing facilities, 10 respondents use the half-pipe, 14 the football field, and 14 the basketball area.
  
- Regarding extra playing field facilities, 8 respondents mentioned tennis, 5 football, 3 hockey and 2 cricket. Several football answers asked for goals at the park or more organised activities. 5 respondents asked for improved skateboard/BMX/dirt tracks.
  
- There was significant support (12 replies) for the sorts of activities typically offered by a youth club (eg table tennis, pool). There was also a clear demand for organised trips (9), with theme parks mentioned several times. Football was mentioned 7 times and music featured 4 times.
  
- 6 parents said they would be interested in helping organise the activities specified above.

## **Conclusions**

The answers and comments provide a contrasting picture – whilst many value Rearsby's quiet environment and sense of community, there is frustration at the lack of facilities. There are plenty of suggestions to plug this gap, mainly focused on outdoor sporting activities, organised indoor activities and trips outside the village. Young people want somewhere to gather, and there is a perception that adults don't understand their needs.

## **Recommendations**

R46 A Youth Forum should be set up to represent the views of young people and deal with the issues raised by the questionnaire including new/alternative use of existing facilities, forming links with other local youth/sports clubs and group bookings and transport for theme parks/sporting events.

R47 The provision of activities for young people in a redeveloped village hall should be pursued in line with the requirements of the January 2004 Village Hall Redevelopment Questionnaire.

R48 The provision of a temporary and permanent meeting place for 12-18 year-olds should be considered.
